

Code of Conduct

UDSD Administrative Guidelines

A formalized code of behavior exists for our elementary school students. This Elementary Code of Conduct is based on the premise that students, parents, teachers, and administrators must assume equal responsibility for establishing and maintaining acceptable behavior in the schools. The policy seeks to promote positive behavior that will enable students to achieve their potential within the most conducive atmosphere for learning. The code of conduct is based on the research in two specific areas: Positive Behavioral Interventions and Supports (PBIS) and Response to Intervention and Instruction (RtII). PBIS aims to prevent inappropriate behaviors through the teaching and reinforcing of appropriate behaviors. It is consistent with the core principles of RtII in that it offers a range of interventions that are systematically applied to students based on their levels of need. PBIS, like RtII, is grounded in differentiated instruction. Both approaches establish components at the universal (Tier 1), targeted group (Tier 2) and the individual (Tier 3) levels.

The Elementary Code of Conduct is as follows:

The following is not intended to be inclusive of all acts of misconduct. Repeated instances of any misbehavior listed increase the punishment at the discretion of the administrator involved. Any disruption to the educational process will be treated as a violation of the Elementary School Discipline Policy. When students are assigned a teacher/administrative detention, they are required to serve that detention instead of any other school activity. Suspensions are in effect the full 24 hours of each day the student is suspended. When suspended, the student is considered trespassing if on any school district property. These Administrative Guidelines are in no way intended to diminish the authority of the School District to refer a pupil to a due process hearing under Policy 233.

Level I (Tier I) - Behaviors that impede orderly classroom procedure. The following list indicates the types of interventions and replacement behavior strategies that staff may implement to provide support and address violations: Parent Letter with Discipline Update; Replacement Behavior Detention; Letter of Apology; Parent Conference, Student Teacher Conference, Conflict Resolution Meeting; Restorative Practice Questions, Morning Meeting Discussion of school/class rules; Review Pillars of Community; Office Time Out With Work; Review of Code of Conduct; Stop and Think; Check In Check Out; Truancy Elimination Meeting.

Level II (Tier II) - Behavior whose frequency or seriousness disrupts the learning climate of the school. The following list indicates the types of interventions and replacement behavior strategies that staff may implement to provide support and address violations: Replacement Behavior Detention AM/PM; Character Education Class Followed by a Behavior Book; Teacher with Student Behavior Book; Lunch Buddies; Second Step; Social Work Referral; Parent Conference; Club Ophelia/Club Hamlet Mentor Programs; Conflict Resolution; Check In Check Out

Disregard of school rules (behaviors in: hallways, playground, assemblies, cafeteria, bathrooms)	Teacher intervention and parent contact Administrative referral/ detention

Level III (Tier III) - Behavior which may threaten the health, safety, or welfare of a member of the school community. The following list indicates the types of interventions and replacement behavior strategies that staff may implement to provide support and address violations: SAP; ABCs; Student/Parent/Teacher Conference; Restorative Practice Questions; SST Paperwork; or Restorative Practice Questions

Verbal Assault (profanity, racial/ethnic harassment, threats)	Administrative referral/ detention/suspension
Sexual Harassment	Administrative referral/ detention/suspension
Bullying	Administrative referral/ detention/suspension
Leaving the school grounds (between 8:50-3:15)	Parent contact/ Administrative referral/ detention/suspension

Possession of tobacco products/ matches/lighter	Administrative referral/ detention/suspension
Smoking, chewing or other use of tobacco products is prohibited within the Upper Darby schools and on school grounds	Parent contact and confiscation, turn in to office together with student's name/ suspension
Throwing objects on school premises	Teacher discipline and parent contact/detention/suspension
Throwing objects on/at school vehicles	Administrative referral/ detention/suspension
Theft/Extortion	Administrative referral/ detention/suspension and restitution
Vandalism	Suspension and/or expulsion/ restitution/police referral
Instigating a fight	Administrative referral/ detention/suspension
Fighting	Administrative referral/ detention/suspension

Level IV (Tier IV) - Behavior that threatens the health, safety, or welfare of members of the school community. The following list indicates the types of interventions and replacement behavior strategies that staff may implement to provide support and address violations: Possible Evaluation; SAP; SST Paperwork

Assault (physical)	Suspension and/or expulsion/police referral
Terroristic threats	Suspension and/or expulsion/police referral

Arson	Suspension and/or expulsion; District guidelines and police referral

Drugs and Alcohol (possession/
dispensing/sale or use) including
