Good afternoon, Upper Darby School District Families, Teachers, and Staff

Upper Darby School District received an application for the Vision Academy Charter School of Innovation on November 12, 2020. The Upper Darby School District parents and community are invited to review the application, which is posted on our website at <https://www.upperdarbysd.org/Domain/2061>.

The District has established an Application Review Committee to consider the application. As part of this process, members of this Committee will schedule a site visit and conduct an interview with the applicant. A special Board meeting (first hearing) has been scheduled for **TOMORROW, December 22, 2020 at 6:00 p.m.** at which time the applicant will provide a public presentation. A special meeting (second hearing) has been scheduled for January 26, 2021 at 5:00 p.m., to be held just prior to the regularly scheduled School Board Committee Meeting at which time the District will review the application and consider public comments. The Board will vote on the resolution at a regularly-scheduled Board meeting on February 9, 2021 at 7:30 p.m.
