The District has established an Application Review Committee to consider the application. As part of this process, members of this Committee have had a site visit and conducted an interview with the applicant. A special meeting (second hearing) was held on January 26, 2021 at 5:00 p.m., prior to the regularly scheduled School Board Committee Meeting. The District reviewed the application and considered public comments. Comments received up to the close of the public comment period will be read into the record.

Public comments will be considered up until the February 9th Board meeting under the “Old Business” report. To make a public comment on the charter school application at the February 9th meeting, please submit your comment under the “Old Business” report.
