DATA & IMPACT

Pre-tests and post-tests from our 11-week TAPS Academy show the following impacts:

- 64% believe that Police will treat all fairly
- 59% believe that Police will respect "me"
- 44% felt more connected to Police
- 38% reported increased respect for the Police

THE TAPS STORY

In 2011, Houston Police Department Chief, Charles McClelland, addressed the need to increase focus on police and teen relations. Assistant Chief Brian Lumpkin volunteered to lead the effort with the help of Officer Treva Mott, and reached out to Criminologist Dr. Everette Penn of University of Houston-Clear Lake to partner in this initiative.

In looking at other teen and police relation programs, Lumpkin, Mott & Penn decided try something different. Teen and Police Service Academy would focus on Houston's most at-risk youth, those who do not come with letters of recommendation, but with juvenile records. The theoretical mission of TAPS would be to reduce the social distance between police and at-risk youth through curriculum, dialogue, interaction, and trustbuilding exercises.

Several months later, HPD received funding from the US Department of Justice COPS Office to take the Teen and Police Service Academy from concept to classroom.

With great determination, HPD offered the very first TAPS Academy at HISD's alternative school, Beechnut Academy, in the spring of 2012. Several years later, as the original COPS grant began to come to an end, Dr. Penn saw the impact that TAPS was having on our community and decided to continue carrying the TAPS torch by re-positioning TAPS Academy from a grant-funded *program* to a 501c3 non-profit in 2015.

Today, TAPS provides programming to youth of all backgrounds, including our TEA Accredited TEEN POL class, TAPS Clubs, Summits & Camps, and is effectively reducing the social distance between police officers and their communities across Texas through our SB-30 Community Safety Education Act class for the public.
